Instructor Kim Collins - Bio

Background: Kim has been training dogs for over 25 years. She owns and operates Pawsitive Steps Canine Sports Centre in Prince George, BC, a training facility dedicated solely to the promotion of positive, non-aggressive training techniques for pet and performance dogs.

Kim's teaching background comes from spending 20 years as a dance teacher and choreographer. She now devotes herself full time to

helping people and their dogs develop positive relationships through education, training and canine sports.

Kim competes in AAC, UKI,CKC and USDAA Agility. Kim has had an impressive agility career over the last 20 years, winning both the *USDAA National Agility Championship* and *four Canadian National Agility Championships* along with *15 Regional Agility Championships* with five different dogs to date.

She has been an AAC Masters level judge since 2000. Kim has also competed in CKC Obedience and CARO Rally Obedience earning multiple titles with multiple dogs.

Kim shares her life with her husband Rob and their dogs ranging in age from 1 to 14 years old. Currently the household is six border collies.

Continuing Education: Kim continues to contribute her knowledge back to the agility community she loves by traveling and teaching seminars all over Canada. She also hosts an annual *Agility Camp* for Puppies and Novice dogs right through to Masters/International level dogs. To ensure that her seminar content is always the most up to date training methods, she regularly attends seminars and workshops presented by many of the top agility handlers and trainers in the sport.

International Experience: Kim was a member of the Agility Association of Canada's 2004 Canadian World Team with two of her dogs, Bryn and Feyd, and traveled to Valencia, Spain to compete. Kim was the Captain and Coach for the CKC Agility Team Canada 2010 and 2011. This team represents Canada at the FCI World Championships, the largest Agility World Championship for our sport. Kim was also the Coach for the 2011 WAO Agility World Team competing in England May 2011. Kim and her border collie Fenway qualified 2nd overall for the 2017 Canadian EO Team, as well as 2nd overall for the 2018 WAO Team where they were a part of the three dog team that won a silver medal and then came 6th overall for Games. At the 2018 UKI Canadian Open Fenway won the Pentathlon win on spot as well as being first place overall for points 24" dog for the 2019 Canadian WAO team.

Kim's book *"From the Ground Up"* an agility foundation training manual, came out in July of 2006 and can be ordered through Dogwise. Kim has written articles on the sport of agility for both Clean Run and DogSport magazines and teaches online as well as in person.

RELEASE AND WAIVER OF CLAIMS

Release of Liability and Indemnity and Indemnity Agreement (for Pawsitive Steps Canine Sports Centre).

By Signing This Document You Will Waive Certain Legal Rights, Including the Right to Sue. **PLEASE READ CAREFULLY. RE: DOG TRAINING CLASSES/EVENTS** to be held at **Pawsitive Steps Canine Sports Centre**, Located at 1816 Old Cariboo Hwy Prince George, BC (hereinafter referred to as "the Classes")

TO: Pawsitive Steps Canine Sports Training (Centre) and its Executive, Directors, and Members; AND TO: The Instructor(s) (All of whom are hereinafter collectively referred to as "the Releasees")

The undersigned who is a spectator or participant in dog training activities including but not limited to Agility and Rally Obedience, in consideration of use of facilities covenants and agrees as follows:

General Release. The undersigned hereby releases and waives any claims that the undersigned may now or hereafter have against the dog training facility Pawsitive Steps Canine Sports, dog training activity sponsor(s), Kim Collins, her instructors or their assigns from and against any and all liabilities, losses, damages, costs or expenses of whatever kind or nature, including attorney's fees, which the undersigned may incur as a result of any injury to the undersigned or their dog(s), or personal property of the undersigned as a result of the undersigned's activities undertaken at said facility including, without limitation, personal injury and damages thereof including loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress and any and all medical expenses.

ASSUMPTION OF RISK. The undersigned acknowledges and understands that the dog training activities undertaken involve potential risk of personal injury and injury to personal property including dogs which may result from the undersigned's participation in dog training activities. Such injuries may be caused by other participants, the undersigned, facility conditions including, but not limited to, uneven or damaged terrain, the presence of moisture or mud, obstacles and obstructions upon or under the terrain and other natural or man-made conditions which may be hazardous to the undersigned or create hazards to the undersigned's activities. The undersigned further acknowledges that these dog training activities are potentially dangerous and assumes all risk of injury and/or damage which may result from any reason whatsoever thereby.

BINDING EFFECT. The foregoing provisions shall be fully binding upon and shall be effective against the undersigned, its heirs, successors, legal representatives or assigns and shall apply to the actions of the undersigned personally, the undersigned's family, guests, employees or agents.

In consideration of the Releasees accepting my application for membership/participation: I HEREBY AGREE AS FOLLOWS:

1. TO WAIVE ANY AND ALL CLAIMS that I may have against the Releasees;
2. TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY for any loss, damage, injury or expense that I may suffer or that my dog may suffer or that my next of kin may suffer as a result of my participation in the Classes due to any cause whatsoever, INCLUDING ANY NEGLIGENCE ON THE PART OF THE RELEASEES;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage, personal injury or death to any third party, or their dog, resulting from my participation in the Classes;
4. THAT this Release of Liability shall be effective and binding upon my heirs, next of Kin, executors and administrators and assigns in the event of my death.
5. That I have read and will abide by all the Rules of Conduct stated in this contract.

I am of the full age of nineteen (19) years and I HAVE THE LEGAL AUTHORITY to sign on behalf of any next of kin which may accompany me to the Classes and I HAVE READ AND UNDERSTOOD THIS RELEASE OF LIABILITY PRIOR TO SIGNING IT, and I am aware that by signing this Release of Liability I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators and assigns may have against the Releasees.

I hereby agree to abide by the rules of Pawsitive Steps Canine Sports Centre, that no dog shall be physically or verbally reprimanded while engaged in any activity sponsored by or affiliated with Pawsitive Steps Canine Sports Centre, or while on the premises owned, leased or rented by Pawsitive Steps Canine Sports Centre. I further understand that any violation of this agreement could lead to the immediate termination of my involvement in the event or activity (including being asked to leave the premises) without refund of any monies paid for that event or activity.
